

# Publishing licensing information



This leaflet gives general information on the use of Ordnance Survey mapping and should be read in conjunction with our publishing licence. Please see our website for further information.

## Copyright

Ordnance Survey products are protected by © Crown copyright, which exists for 50 years from the end of the calendar year in which they are first published. Crown copyright is held by The Controller of Her Majesty's Stationery Office, who has passed responsibility for managing Crown copyright in Ordnance Survey material to our Director General. Our Director General is also responsible for deciding the terms and conditions for reproducing this material. We have invested a great deal in our products. Our copyright policy must protect this investment and make sure we get a fair financial return from anyone using our products; they therefore contain fingerprinting and coding protection techniques to enable us to identify publications that have used our mapping without permission.

Please note that when creating your own mapping in any form, that is paper, CD, DVD and so on, any reference to Ordnance Survey material in its creation is subject to Crown copyright and requires a licence. For example:

- tracing;
- referring to an Ordnance Survey map in order to create your own; and
- photocopying or scanning.

## How to use our material

#### **Key licence terms**

Your licence fee will be calculated on the amount of mapping that you use in your publication and the number of copies of the publication printed. Fees are payable in advance. The licence only covers the publication it is granted for and the print run specified. Separate permission is required for any reprints or new publications. Discounts may be available depending on the mapping content of your publication and the number of copies printed. The minimum licence fee is **£47.50 plus VAT**. We assess our licence fees depending on the type and the amount of mapping used, these are defined as 'facsimile mapping' or 'redrawn mapping'.

Facsimile mapping is a copy or reproduction of Ordnance Survey mapping that is the same or similar in style and appearance to Ordnance Survey mapping, albeit that some alterations or additions may have been made. Please note that size restrictions do apply on the use of facsimile mapping; for further information please read the terms and conditions on our website; alternatively, we can send you a printed copy. Redrawn mapping means the use of mapping within a publication that has been redrawn or compiled with reference to Ordnance Survey maps but are not exact or facsimile copies and do not look like the Ordnance Survey maps. Redrawn mapping includes mapping that has been reproduced by another publisher from Ordnance Survey material, for example, Geographers' A-Z Map Co Ltd, Estate Publications, Philips and so on.

If you wish to reproduce other publishers' mapping you must obtain permission from the relevant publisher as well as Ordnance Survey. Please note that both publishers are entitled to charge a licence fee. Some publishers collect the licence fee on our behalf, but if this applies you will be advised at the time of your request.

#### Additional information

**A7** – Extracts of A7 or less may be reproduced free of charge in a paper publication subject to a limit of 1 000 copies for non-commercial purposes by private individuals only.

**1:1 000 000 scale mapping –** For publications that contain 'redrawn mapping' at a scale of 1:1 000 000 or less, a licence fee may not be payable provided the mapping is sourced from 1:1 000 000 scale Ordnance Survey mapping with a similar specification to Ordnance Survey's MiniScale® dataset.

#### Academic and student research

A licence fee may not be payable for this type of request subject to certain conditions. Please refer to the Customer Contact Centre for further details.

#### Fair Dealing and copying

You can make copies of Ordnance Survey mapping in accordance with the principle of 'fair dealing' set out in the Copyright, Designs and Patents Act 1988. These entitle you to make copies for the purpose of criticism, review, news reporting and research for a non-commercial purpose. If you make a copy for any other of these purposes you must, where possible, provide an acknowledgement in the following form: 'Reproduced by permission of Ordnance Survey on behalf of HMSO. © Crown copyright. All rights reserved.' It is your responsibility to ensure your activities comply with the relevant statutory provisions. Ordnance Survey will allow individuals to make up to four A4 copies for private study. Where further copies of these maps are required, permission should be sought from us and a charge maybe made if further permission given.

#### Aerial photography

We calculate the licence fees for taking copies of our aerial photography in the same way as our other copyright material.

#### Scanning

Ordnance Survey will allow scanning of Ordnance Survey mapping where this is done to put a publication into the permitted form as stated in the publishing licence (that is paper, CD, DVD and so on) on which it is distributed. No scanning of any Ordnance Survey paper mapping shall be permitted where the same Ordnance Survey data is available

### Out of copyright

You are permitted to copy Ordnance Survey mapping that is out of copyright but we ask that you contact us for confirmation that the mapping is over 50 years old; you will be given the acknowledgement to show on the reproductions.

Further details on the use of the above can be found in the terms and conditions of the publishing licence on our website.

#### Reproduction charge

The table below shows the reproduction charge for the total map area reproduced in your publication. The unit charge is multiplied by the print run and any applicable discounts are applied when calculating the licence fee. Please note that the minimum licence fee is £47.50 plus VAT.

Examples of reproduction charge:

1. Reproduce an A4 extract of OS Landranger Mapping in a book with a print run of 5 000.

9p per copy x 5 000 = £450.00 plus VAT

2. Reproduce an A3 extract of redrawn mapping on a CD-ROM with a print run of 1 250.

5p per copy x 1 250 = £62.50 plus VAT

3. Reproduce an A5 extract of OS Explorer Mapping with a print run of 35 000.

5p per copy x 35 000 – 10% discount = £1575.00 plus VAT.

#### Discounts

- The reproduction charges shown above will be subject to a 50% discount where the licensed mapping is less than 10% of the overall text and pictorial content of the publication.
- 2. The following volume discounts apply and will be calculated separately for each publication (or version of the publication) based on the number of copies printed:

**10%** discount if you print between 10 000 and 49 999 copies.

20% discount if you print between 50 000 and 99 999 copies.

**30%** discount for 100 000 copies or more.

3. Registered charities are entitled to a 20% discount on our charges in addition to any other discount that may apply.

#### Supply and licensing of our products

Please note that the publishing licence is for persons who wish to reproduce a single publication that contains Ordnance Survey mapping that is distributed on paper, CD, DVD, PDF, TIFF or other 'read only' format. If you wish to acquire any Ordnance Survey mapping from Ordnance Survey for the production of your publication then this will be subject to another licence or contract with Ordnance Survey.

#### Illegal use of our mapping

Copying our maps or using our data without permission may constitute a criminal offence. If you do so you may be subject to legal action for copyright infringement and ordered to deliver to us or destroy all infringing copies as well as liable to pay damages and legal costs. We calculate our compensation in line with standard royalty charges applicable plus our costs.
